

UAE ONLINE VISA APPLICATION PROCEDURE

FOR GUESTS ATTENDING AIRPORT EXCHANGE 2011, ABU DHABI

Visa on Arrival

If your country of nationality appears on the list below, no advance visa arrangements are required to visit the UAE. Simply disembark your flight at Abu Dhabi International Airport and proceed to Immigration, where your passport will be stamped with a 30-day Tourist visa.

In addition to nationals of the countries listed above, citizens of the GCC nations of Bahrain, Kuwait, Oman, Qatar and Saudi Arabia are eligible for visa on arrival at Abu Dhabi International Airport.

Travellers from countries not listed above will need to arrange a visa in advance of travel via the UAE Visa Request Form for Tourist Visa mentioned below.

British Overseas Passport Holders: All guests who are in possession of British Overseas Passports are not exempt from the requirement of visas to enter UAE. Such guests are treated as non UK Nationals and hence need to have visas processed prior to arrival in UAE.

Mandatory Requirements for online visa application:

Passport Copy

- ❖ Please enclose colour copy of your Passport pages containing details of Full name, Nationality, Date and Place of birth, Passport number, Date of issue & Expiry.
- ❖ Your Passport must be valid for a minimum period of 6 months at the time of travel.

Photograph

- ❖ Size 4.3 * 5.5 cms
- ❖ Only colour photograph with white background will be accepted.
- ❖ 80% of your face should be visible.

- ❖ Photograph must not exceed 40 kb and be in JPG

Etihad Airways Confirmed Ticket

- ❖ Please enclose confirmed ticket travelling into Abu Dhabi and onwards from Abu Dhabi with Etihad Airways.
- ❖ Only round trip ticket will be accepted.

Important Information Related to UAE Visa

- ❖ TT Services is providing this facility for Etihad Airways Guests. TT Services do hereby declare that they have no role whatsoever in the assessment of a visa application, which is the sole prerogative of the Government of UAE/Immigration Department. Therefore, neither TT Services nor Etihad Airways will in any manner be liable or responsible for any delay in the processing or rejection of any visa applications.
- ❖ This facility is open for persons visiting UAE travelling on the Etihad Airways and fulfilling the eligibility conditions announced from time to time by the UAE Authorities.
- ❖ Issuance and approval of a visa is solely regulated by Government of UAE and governed by their rules and regulations that may be amended from time to time. Etihad Airways will sponsor the guest application subject to guest fulfilling the eligibility conditions.
- ❖ **Guests desirous of being sponsored for a visa by Etihad Airways should be holding a valid ticket travelling into Abu Dhabi and onwards from Abu Dhabi issued by Etihad Airways and booked to travel on Etihad Airways. TT Services will not be responsible for and will not be liable for Guests not been able to travel due to denied boarding offloading, cancellation of flight, delays or and any other cause or circumstances beyond TT Services control. Neither Etihad Airways nor TT Services shall be liable in the case of any change in the date of travel not being communicated to us.**
- ❖ The Guest will be required to fill in a Visa Application Form accurately and submit the same with valid passport and necessary documentation as specified in the Visa Application Form. Guests must hold valid travel documents and comply with the requirements of the Government of UAE/ Immigration Authorities.
- ❖ Inaccurate details will result in delay in processing, inconvenience to guest on arrival at UAE, and additional charges may be levied by authorities.
- ❖ Once application form is submitted or processed, any correction will be considered as fresh application and visa fee will be collected accordingly.
